Apprenticeship Incentive Grant and Apprenticeship Completion Grant

The Apprenticeship Incentive Grant offers \$1,000 to eligible apprentices who successfully complete their first and/or second level of apprenticeship training in a designated Red Seal trade, to a maximum of \$2,000.

The Apprenticeship Completion Grant offers \$2,000 to eligible apprentices who successfully complete their apprenticeship training and receive their journeyperson certification in a designated Red Seal trade on or after January 1, 2009.

By combining the two grants, apprentices could be eligible for up to \$4,000 upon certification in a designated Red Seal trade.

### **Apprenticeship Incentive Grant for Women**

**Note:** The Apprenticeship Incentive Grant for Women (AIG-W) pilot project will end on March 31, 2023. Applications will not be accepted after this date.

Apprentices whose first year (level/block) or second year (level/block) progression date occurs after the AIG-W pilot project ends on March 31, 2023 may be eligible for the Apprenticeship Incentive Grant (AIG).

Project funding for organizations providing supports to women wishing to pursue a career in the skilled trades will be available under the Canadian Apprenticeship Strategy.

The <u>Apprenticeship Incentive Grant for Women</u> is a taxable cash grant of \$3,000 per year/level (or equivalent) up to a maximum amount of \$6,000 per person.

To be eligible for the AIG-W, you must:

- be a Canadian citizen, permanent resident, or protected person
- not be a high school student
- self-identify as a woman
- have the required AIG-W <u>supporting documents</u>
- register with your provincial/territorial apprenticeship authority as an apprentice in a <u>designated Red</u>
  <u>Seal</u> trade having low female representation
- have progressed in your training in designated Red Seal trades between April 1, 2018 and March 31, 2023, and
- provide proof that you have successfully completed either the first year (level/block) or second year (level/block) (or equivalent) of apprenticeship.

**If you progressed between January 1, 2019 and December 31, 2020**, your deadline to submit an application is: 18 months following your date of progression.

**If you progressed between January 1, 2021 and March 30, 2022**, your deadline to submit an application is: 12 months following your date of progression.

If you progressed on or after March 31, 2022, your deadline to submit an application is: March 31, 2023. You should apply by this date, even if you have not received supporting documents from your apprenticeship authority.

In all cases, the deadline for submitting supporting documents is 12 months from your application deadline.

# **Apprenticeship Incentive Grant (AIG)**

The <u>Apprenticeship Incentive Grant (AIG)</u> is a taxable cash grant of \$1,000 per year or level, for a lifetime maximum amount of \$2,000 per person.

To be eligible for the AIG, you must:

- be a Canadian citizen, permanent resident, or protected person
- not be a high school student

- have the required AIG supporting documents;
- register with your provincial/territorial apprenticeship authority as an apprentice in a <u>designated Red Seal trade</u>, and
- provide proof that you have successfully completed either the first year (level/block) or second year
  (level/block) (or equivalent) in a designated Red Seal trade

**If you progressed between January 1, 2019 and December 31, 2020**, your deadline to submit an application is: 18 months following your date of progression.

**If you progressed on or after January 1, 2021**, your deadline to submit an application is: 12 months following your date of progression.

# **Apprenticeship Completion Grant (ACG)**

The <u>Apprenticeship Completion Grant (ACG)</u> is a one-time taxable cash grant lifetime amount of \$2,000 per person for registered apprentices who complete their apprenticeship training and obtain their journeyperson certification.

#### To be eligible for the ACG, you must:

- be a Canadian citizen, permanent resident, or protected person
- not be a high school student
- have the required ACG <u>supporting documents</u>
- show that you have completed an apprenticeship program as a registered apprentice in a <u>designated</u> Red Seal trade, and
- provide proof of your journeyperson certification in a designated Red Seal trade

If you completed your program between January 1, 2019 and December 31, 2020, your deadline to submit an application is: 18 months following your date of progression.

If you completed your program on or after January 1, 2021, your deadline to submit an application is: 12 months following your date of progression.
